CLÁUSULA PRIMEIRA:

1.1. As partes resolvem aditar o Termo de Contrato nº **038/SMSU/2023**, visando o acréscimo de 24,93% (vinte e quatro inteiros e noventa e três centésimos por cento), **272 (duzentos e setenta e duas) unidades**, de pistola calibre 9 mm, pelo valor unitário de **R\$ 5.583,00 (cinco mil quinhentos e oitenta e três reais)**, perfazendo o valor total de **R\$ 1.518.576,00 (um milhão quinhentos e dezoito mil quinhentos e setenta e seis reais)** e passando o valor total do Contrato para **R\$ 7.609.629,00 (sete milhões seiscentos e nove mil e seiscentos e vinte e nove reais)**.

2.1. As despesas na execução deste Termo aditivo onerará a dotação orçamentária nº 38.10.06.181.3013.2.192.4.4.90.52.00.00.1.501.9001.1.
